In order to ensure better employability and industry-readiness of the Graduates of B.Com. CS program, the Department proposed to improve the curriculum benchmarking it with the Professional Programs such as Company Secretary and Cost & Management Accountancy. As such, the curriculum is revisited and certain sweeping changes have been made – by introducing new courses and improvising the syllabi of many courses. The Honourable members Board of Studies have expressed their appreciations for the changes made commenting that it reflects the current demands of the Industry and Accounting Profession.
